In consideration for participating in Alpine SoCal, I/we hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, Alpine SoCal, their officers, servants, agents, volunteers, (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or transportation to and from said activity.

I/We are aware of the risks and hazards that are connected with traveling on the road to and from such events that from time to time will be available to me/us by Alpine SoCal. I hereby elect to voluntarily participate in activities that may be available to me as a member of Alpine SoCal.

I/We further hereby agree TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, which may arise from my participation in the driving to and from such activities.
